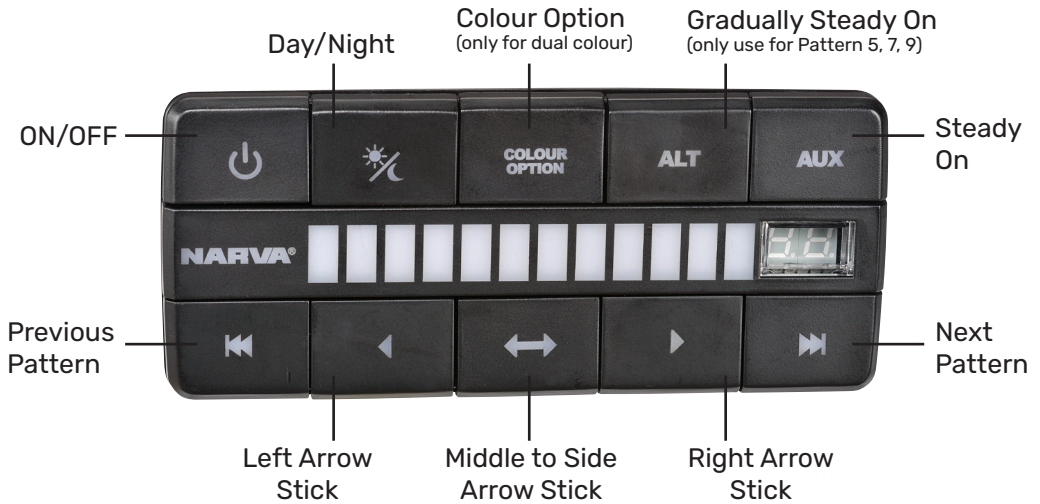

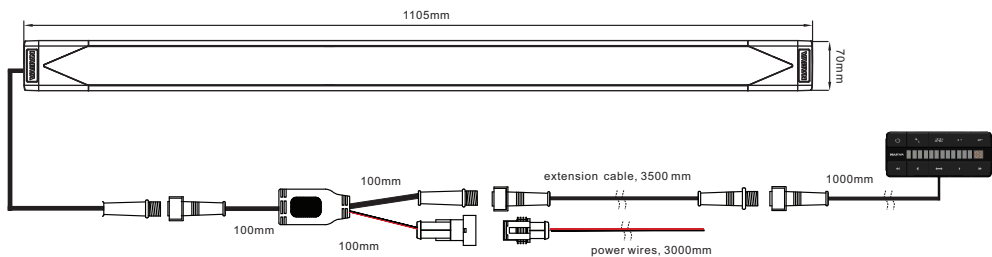

FLASH PATTERNS

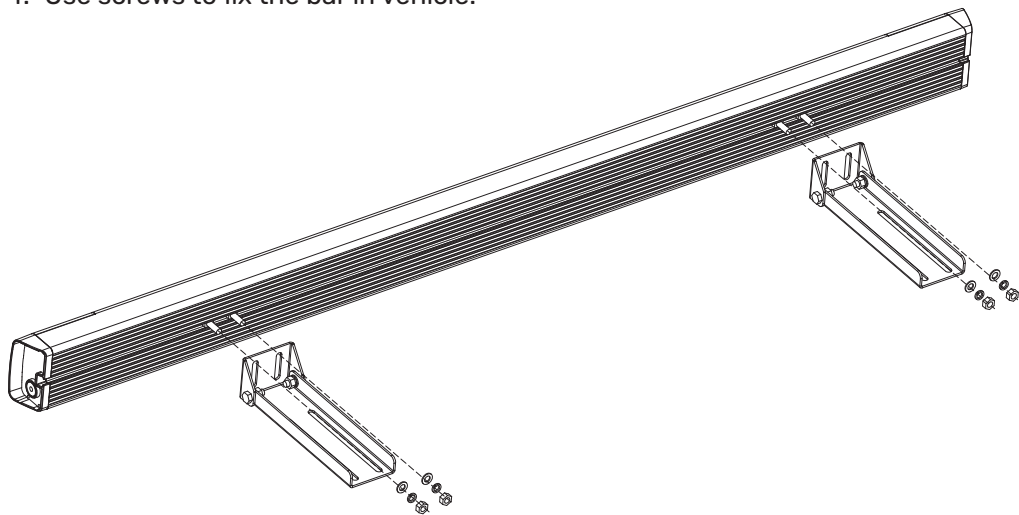
#1	Single flash half-half alternate (ECE R65)
#2	Double flash (SAE)
#3	Quad flash (SAE)
#4	Centre -out alternate
#5	Left arrow stick
#6	Left arrow stick - gradually steady on
#7	Right arrow stick
#8	Right arrow stick - gradually steady on
#9	Middle to side arrow stick
#10	Middle to side arrow stick - gradually steady on
#11	Steady on

WIRING



MOUNTING

1. Use M6×16mm bolts to install the big and small bracket together.
2. Install 4 M6×16mm bolts on bar.
3. Install the bracket on bar and use provided nuts and washers to tighten brackets.
4. Use screws to fix the bar in vehicle.
