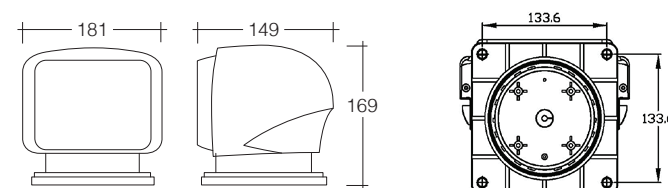

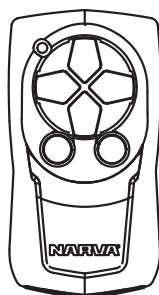
Handheld Wireless Remote

HANDHELD WIRELESS REMOTE PROGRAMMING PROCESS

1. Switch off DC power
2. Make sure there is NO transmitter operating at the same time.
3. Switch on DC power then press Remote up ▲ and down ▼ button once synchronously.
4. Searchlight will flash to acknowledge the Remote.
5. To program the second Remote (one searchlight accept 4 units wireless remote at most), within five seconds after the first Remote programmed, press the second Remote up ▲ and down ▼ button.

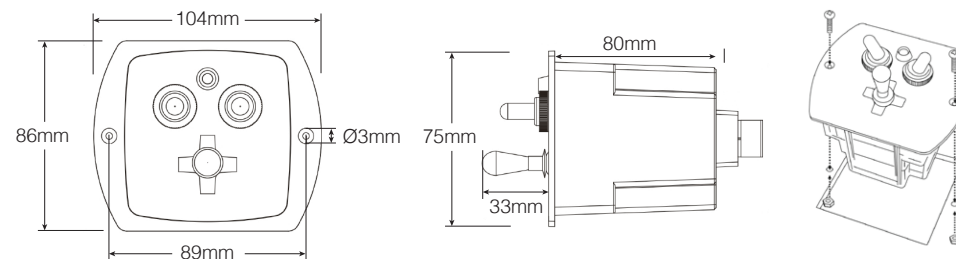
