


## **IMPORTANT SAFETY INFORMATION**

- Remove negative battery cable before installation.
- Ensure lamps are fitted using the appropriate wiring harness or an equivalent auxiliary wiring system.
  We strongly recommend to use the Ultima Wiring Harness (74405 and 74406)
- Ensure the lamps are mounted securely to a solid surface on the vehicle's roof.
- Cables connected to the lamp must not be subjected to wear or other damage.


# ASSEMBLY




1 Unpack your high performance Ultima 8" twin pack and 24" light bars




2 Remove M8 Torx screws and flat washers 3 Remove light bars from bracket




- 4 Add the 1 x M8 grub screws to one end of 6 Now you're ready to fit the 40" Joiner. the Ultima 24" and 8" light bars as shown above and tighten up securely
- 5 Repeat to other side




Position the 40" Joiner as shown above




- 7 Place one end of light bar into the hole in Joiner
- 8 Assemble the M8 spring washer and flat nut onto the grub screw. Tighen securely




9 Repeat the same order to other side. Ensure the flat nuts are done up tight




# MOUNTING




- 1 Insert M8 coach bolt and custom washer into slotted recess in diecast bracket
- 2 Repeat assembly to other diecast bracket




- **3** Fit the diecast bracket to the light bar making sure to line up the holes
- 4 Insert the M8 Torx screws and flat washers
- 5 Ensure the M8 Torx screw are done up tight



- 6 Choose a solid surface on the vehicle's roof to mount the light bars
- 7 Secure the lamp by using rubber pad, extra large flat washers, M8 spring washers and nuts



8 Ensure the M8 nuts are done up tight
