Brown & Watson International Pty Ltd of 1500 Ferntree Gully Road, Knoxfield, Vic., telephone (03) 9730 6000, fax (03) 9730 6050, warrants that all products described in its current catalogue (save and except for all bulbs and lenses whether made of glass or some other substance) will under normal use and service be free of failures in material and workmanship for a period of one (1) year (unless this period has been extended as indicated elsewhere) from the date of the original purchase by the consumer as marked on the invoice. This warranty does not cover ordinary wear and tear, abuse, alteration of products or damage caused by the consumer. This warranty does not cover abuse or alteration of the product by the consumer.

To make a warranty claim the consumer must deliver the product at their cost to the original place of purchase or to any other place which may be nominated by either BWI or the retailer from where the product was bought in order that a warranty assessment may be performed. The consumer must also deliver the original invoice evidencing the date and place of purchase together with an explanation in writing as to the nature of the claim.

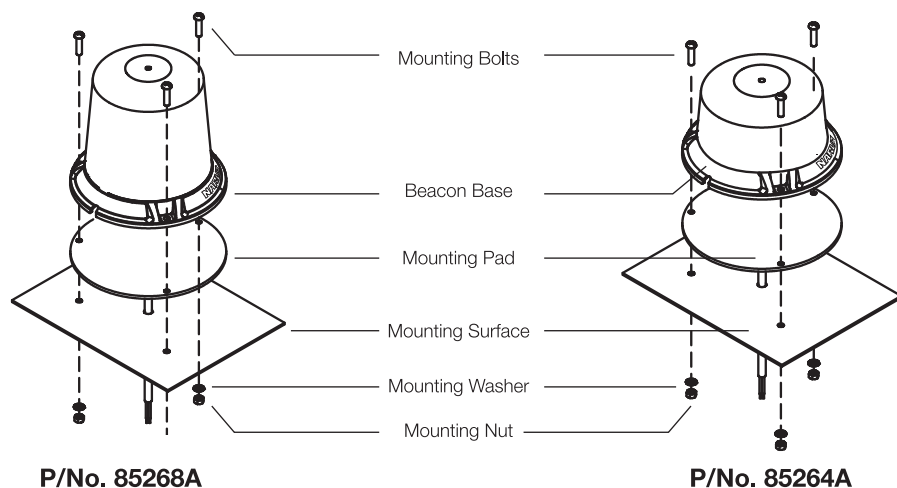

Instructions, Specification & Warranty Details

INSTALLATION – FLANGE BASE

- 1 Prepare a suitable area on the vehicle's surface by wiping it clean to prevent scratching.
- 2 Drill a 10mm ($\frac{3}{8}$ ") hole into the surface for the wires to exit through for connection to a power source. Alternatively, the wires can be directed through the side of lamp's base for connection to a power source.
- 3 Using the lamp as a template, drill three holes for fitment and secure to the surface using the supplied mounting bolts. A mounting pad is included and can be installed between the surface and the lamp.
- 4 Route the wires as planned in step 2. Connect the red (+) wire to 12/24VDC and the black (-) wire to ground. Test.



WIRING

- RED:** To 12/24VDC (+) (Warning Mode 1), Fuse = 7.5A (85264A, 85268A)
- BLACK:** To chassis ground (-)
- YELLOW:** Synchronization & Flash Pattern Selection
- WHITE:** Low power
- GREEN:** To 12/24VDC (+) (Warning Mode 2). Fuse as above

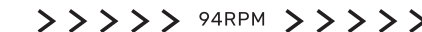

FLASH PATTERN SELECTION

Users may select and save one Flash Pattern for each Warning Mode. While activating a Warning Mode, momentarily apply YELLOW wire to +VDC:

- ☐ Once to the next pattern
- ☐ Quick three times to FP#1 (refer to Flash Pattern chart)

• Low Power

Users may activate Low Power Function from 100% output to 40% for each Warning Mode. While activating a Warning Mode, applying WHITE wire to +VDC to activate it.

SETTING MODE

- 1.To enter Setting Mode, power off the unit completely and power up by applying RED (or GREEN or RED+GREEN) and YELLOW wires simultaneously, and then remove Yellow wire.
- 2.To save and exit the setting, simply disconnect the power after operation.

• Grouping

After entering Setting Mode, momentarily apply YELLOW wire to +VDC to select product group.

The beacon will display short flashes:

- ☐ Single Flash: Group 1
- ☐ Double Flash: Group 2

• Reset to Factory Default Settings:

While in Setting Mode, apply YELLOW wire to +VDC for more than 5 seconds. The Beacon will display fast short flashes to signify restoring successfully.
